Every project incorporates access to water and toilets, hygiene education, and community development. In Oromia, Ethiopia, the Organization completed the Dawo Kara project, which serves 3,700 people. The Organization also continued progress on the Dima Jeliwan, which is scheduled to be completed in 2018 and will serve 3,800 people. In Bangladesh, 367 water systems serving 17,587 people in urban slum settlements in Dhaka, Chittagong, and Khulna were completed. In the rural Lempira communities of La Mina, Jurtao, El Aguacate, Guayabo, Broton, Zapote, and Santa Rosita, Honduras, 5,142 people gained access to piped water and toilets at every household. Additionally, the Organization's local Honduran partner continues work on a large rural

As part of each visit, Water 1st meets with the staff of the local partner organization to share the evaluation results so that the local partner organization can further improve its efforts in the communities we support. These meetings cover such topics as health education, project operation and maintenance, finance, watershed protection, sanitation, and community organization. These meetings also allow the staff of Water 1st to provide some cross-fertilization of ideas and experience sharing between local partner organizations.
