Every project incorporates access to water and toilets, hygiene education, and community development. In Oromia, Ethiopia, the Organization continued progress on the Dima Jeliwan project, which is scheduled to be completed in 2018 and will serve 3,800 people. In Bangladesh, 426 water systems serving 17,782 people in urban slum settlements in Dhaka, Chittagong, and Khulna were completed. In the rural Lempira communities of El Nuco, Junigual, Solicor, San Francisco, Catulaca, Carrizal y Granadilla, and Cedrales, Honduras, 2,496 people gained access to piped water and toilets at every household. Additionally, the Organization's local Honduran partner continues work on a large rural town project serving 3,800 people and initiated ten

two large projects are expected to finish in 2018. Nine additional projects serving 4,110 people were initiated and will be completed in 2018/2019. The purpose of this program is to provide capital for existing, older systems to expand and upgrade as their populations grow.

Our decision to end funding was based upon our conclusion that the program was at capacity & was not likely to evolve further through our participation. However, our loan program continues & new water points and toilets are being constructed using revolving loan funds. Repaid loan funds from previous water projects has allowed our local partner organization to drill two new wells and install handpumps to serve 2 additional rural communities in the Sundarbans region of West Bengal since our grant funding was discontinued. In 2017, Water First kept in contact with our India partner via email and they reported that all systems are functioning.
